




Cognos Performance Metrics



Report Success Rate


Overall success rate is **91.1%**






Retiring Staffing Analytics

The New Hire Dashboard was modified. This report provides key metrics as well as tabular data to provide details about new hires. The report was first modified to include optional prompts for new hire appointing authority and mission critical occupation tags, as well as new tabs/pages to display new hire data by tag. Next, the report was modified to change the existing value prompts for mission critical occupation and appointing authority to the select and search prompt type. This change is intended to improve performance of the loading of the prompt page. The report was also modified to replace the columns for Tentative Job Offer Response, Tentative Job Offer Response Date/Time, Official Job Offer Response, and Official Job Offer Response Date/Time with Job Offer Type, Job Offer Response, and Job Offer Response Date/Time.

New Hire Detail Report – deployed February 16th and March 16th

The New Hire Detail Report was modified. This report provides tabular data displaying a list of new hires by organization, office, and customer, with detailed information about the request associated with the new hire, new hire status, and completion dates of tasks included in typical onboarding workflows. First, the report was modified to include optional prompts for new hire appointing authority and mission critical occupation tags, as well as new tabs/pages to display new hire data by tag. Next, the report prompt page was modified to change the existing value prompts for mission critical occupation and appointing authority to the select and search prompt type. This change is intended to improve performance of the loading of the prompt page. The report was also modified to replace the columns for Tentative Job Offer Response, Tentative Job Offer Response Date/Time, Official Job Offer Response, and Official Job Offer Response Date/Time with Job Offer Type, Job Offer Response, and Job Offer Response Date/Time.

Account Management Report – deployed February 16th

The Account Management Report was modified. This report provides tabular data displaying user accounts by organization, office, and customer. Detail data is also provided for all users, inactive users, reports only users, service accounts/bots, and users with access to applicant flow data. The report prompt page was modified to combine the previously separate Office and Customer prompts into a single Office/Customer prompt. The prompt was also made optional vs. required. Finally, to more easily distinguish offices from customers, the word "(Customer)" or "(Office)" will appear after the name in the prompt. These changes will ensure differentiation between offices and customers that may share the same name and that only data for offices and/or customers selected appear in the report output.

The Permission Profiles Assigned Report was modified. This report provides tabular data displaying a list of the permission profiles that have been assigned to at least one user. The report was modified to include a required prompt for tenant. The inclusion of this prompt should help to improve performance when loading the prompt page. The report was also updated to include grouping and to modify the report grouping setting to ungroup rows when exporting to Excel.

The User Account Details Report was modified. This report provides tabular data displaying a list of users, including account flags, creation date/time, last log-in date/time, and days since last log-in. The report was modified to include a required prompt for tenant. The inclusion of this prompt should help to improve performance when loading the prompt page. The report was also updated to include grouping and to modify the report grouping setting to ungroup rows when exporting to Excel.

The User Accounts by Office/Customer Report was modified. This report provides tabular data displaying a list of users by user type and by organization and office or customer name, including permission profile details, account flags, creation date/time, last log-in date/time, and days since last log-in as a specific user type. The report was modified to include a required prompt for tenant. The inclusion of this prompt should help to improve performance when loading the prompt page. The report was also updated to include grouping and to modify the report grouping setting to ungroup rows when exporting to Excel.

The report was modified to include a required prompt for tenant. The inclusion of this prompt should help to improve performance when loading the prompt page. The report was also updated to include grouping and to modify the report grouping setting to ungroup rows when exporting to Excel.

The User Accounts with Permission Profiles Report was modified. This report provides tabular data displaying a list of user accounts along with their assigned permission profile by office/customer. The report was modified to include a required prompt for tenant. The inclusion of this prompt should help to improve performance when loading the prompt page. The report was also updated to include grouping and to modify the report grouping setting to ungroup rows when exporting to Excel.

Data Model Changes

Application Last Submitted – will be deployed March 16th

A new query item was added to enable reporting on the last submitted date of an application.

Application Responses – will be deployed March 16th

In support of USA Staffing functionality that allows applicants to update their responses following submission, the underlying Hiring Data Warehouse tables for application responses to announcement questionnaire and assessment questionnaire items have been updated to only include the current/most recent responses provided by an applicant.

Data Model Changes

Assessments – will be deployed March 16th

New query items were added to enable reporting on whether a questionnaire or manual assessment has a passing score as well as details about manual assessments.

Data Model Changes

New Hire Forms and Documents – will be deployed March 16th

New query items were added to be used in combination with New Hire Number as a unique identifier for forms and onboarding documents.

Data Model Changes

Reviews – deployed March 2nd

Functionality was recently added to the USA Staffing interface to enable the deletion of certain reviews (e.g., position description reviews) that have not been sent out to reviewers. (See the USA Staffing Production Release Notes for release 13.9 for additional details.)

In support of the ability for certain reviews to be deleted from the interface, the associated tables in the Hiring Data Warehouse have been updated to include fields to identify when a review has been deleted and to exclude deleted reviews from appearing in reports.

Request Details – will be deployed March 16th

New query items were added to enable reporting on additional details about the request approver and the requester.

- Request Information folder > Request query subject
 - [Time to Hire].[Request].[Request Approver Phone Number]
 - [Time to Hire].[Request].[Requester Email]
 - [Time to Hire].[Request].[Requester Name]
 - [Time to Hire].[Request].[Requester Phone Number]

Certificate Review Metrics Date – will be deployed March 16th

A new query item was added to enable reporting on the maximum certificate review sent date.

API Updates



USA Staffing Data APIs

Time to Hire API – will be deployed March 16th

The Time to Hire API was updated. The Time to Hire API provides detailed data about the time it takes to complete subtasks related to hiring a federal employee through USA Staffing. The API will return data about each request including days to hire and critical time to hire dates. In addition to the data specifically related to the time to hire request, direct links to associated APIs are provided in the returned JSON for the announcements, customers, offices, organizations, requests, new hires, and vacancies APIs. The API was updated to include the Max Certificate Review Sent Date.

Announcement Text API – will be deployed March 16th

The Announcement Text API was deployed. The Announcement Text API provides detailed data about the text of USAJOBS announcements. This API is open to the public and allows users to retrieve summary, hiring path, duties, major duties, conditions of employment, qualifications, education, documents, how to apply, how to apply next steps requirements, evaluations, benefits URL, benefits, other information, appointment type override, position schedule override, exclusive clarification text, and video URL.

USA Staffing Data APIs

Data Dictionary Search Function – will be deployed March 16th

A new search function has been added to the API Developer Platform's Data Dictionary. Users can now find which APIs have which data items using search terms on the data item name or description.





Hiring Data Warehouse Refresh Process



















- A new snapshot is created when the SSIS ETL completes loading the HDW Parent
- A snapshot is a read only, static copy of the HDW Parent
- An individual Cognos report uses the newest snapshot that exists at the time the user clicks "Run"
- Once all reports using an older snapshot have completed, the snapshot is removed



Hiring Data Warehouse Refresh Process

Rolling Snapshots

- Jobs to update data in the HDW are scheduled to <u>start</u> at:
 - o 4:00 AM ET
 - 12:00 PM ET
 - o 8:00 PM ET
- The times at which new data is available for reporting varies based on how long each job takes to complete. Times vary based on:
 - Volume of data to be added or updated
 - Reporting activity while the job is running
- If/when a job takes more than 8 hours to complete (i.e., is running at/beyond the start time of the next job):
 - The currently running job continues to run
 - The job scheduled to start does not kick off
