






Overall Satisfaction

Overall Satisfaction by Quarter








Type(s) of Reports






Retiring New Hire (End of Day)

User License Reporting Support

The **new User License** data package **is now available in Cognos**, and **Staffing Analytics will be retired** following the transition of existing reports to the new data package.

Transition Support

Standard Reports – current standard User License reports will be created to meet the needs met by the existing standard reports.

Custom Reports –

- USA Staffing Reporting teams are analyzing all existing custom reports that use Staffing Analytics and that have been run at least 5 times in the last year.
- Custom reports will be analyzed to develop requirements for new standard reports to meet the needs met by the custom reports.

Information Sharing – once available in Cognos, information about the new User License will be shared at workgroup meetings and any necessary job aids will be posted on the USA Staffing Resource Center.


Retirement –

- Current standard reports will be retired upon delivery of new standard reports.
- Current custom reports will be retired upon confirmation that the reporting need is met by a report using the new User License data package.
- The Staffing Analytics package will be retired following retirement of all reports that use it as a data source.

Announcement Status Dashboard – deployed May 12th

The Announcement Status Dashboard was modified. This report contains visualizations and tabular data showing the status of announcements to support HR user workload management. The dashboard was updated to include USAJOBS job status, concatenated announcement locations, and promotion potential on pages that include tabular data. Additionally, an optional prompt was added to enable filtering on whether the default benefits text was used in the announcements. Finally, a new visualization was added to the dashboard page to show the number of announcements by USAJOBS job status.

The Announcement Status Report was modified. This report contains tabular data showing the status of announcements to support HR user workload management. Additionally, an optional prompt was added to enable filtering on whether the default benefits text was used in the announcements.

Assessment Items and Applicant Responses Report – deployed May 12th

The Assessment Items and Applicant Responses report was modified. This report provides tabular data displaying vacancy and assessment information, a list of applicants, and applicant responses to assessment questions. The report was modified to ensure that all responses to multiple choice – multiple select items are included in the report output. Additionally, an optional prompt for application location was added. Due to these changes, this report should only be run using Excel output to ensure applicant responses are appropriately aligned with assessment items.

Certificate Activity Report – deployed May 12th

The Certificate Activity Report was modified. This report displays tabular data summarizing the number of certificates issued, certificates audited, and selections made. The data is provided by vacancy, year, month, organization, and office. The report was modified to include metrics identifying the total number of certificates on reviews that were returned and the total number of certificates on reviews that were returned and the total number of certificates and grade were updated to be based on the certificate filter series and certificate filter grade rather than the vacancy series and vacancy grade, respectively.

Certificate Review Detail Report – will be deployed May 26th

The Certificate Review Detail Report was modified. This report provides tabular data listing the certificate reviews for a vacancy, including detailed information about review status, reviewers, and reviewer assignments. The report was modified to include columns for the most commonly used certificate filters to enable reporting on the criteria used when issuing a certificate.



At maturity, a second namespace will be available to enable simplified reporting on the number of paid accounts by tenant, organization, and office based on the user's designated primary office.

The User License data warehouse currently refreshes once daily. Future work will update the refresh process to occur 3x per day.
